1. **KamalBazar Municipality Achham**, invites sealed bids or electronic bids from eligible bidders for the construction of KamalBazar Municipality office and Quarter Building Construction Works and Upgrading of RCC Road KamalBazar municipality in Achham under National Competitive Bidding procedures for the following work.

A complete set of Bidding Documents may be purchased from the **KamalBazar Municipality** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, business registration certificate, VAT and PAN registration certificate and tax clearance of fiscal year 2073/074 and upon payment of a non-refundable fee of above mentioned amount till **2075/1/20 (3rd May, 2018) 17.00 hours**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 2000.00. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from DUDBC's web portal [www.edudbc.gov.np](http://www.edudbc.gov.np). Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (PDF format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **KamalBazar Municipality** at 11.00 on 2075/01/09 (22<sup>nd</sup> Apr, 2018).
5. Sealed or Electronic bids must be submitted to the **KamalBazar Municipality** by hand/courier or through PPMO web portal [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on 2075/01/21 (4<sup>th</sup> May, 2018). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2075/01/21 (4<sup>th</sup> May, 2018) at the office of **KamalBazar Municipality**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format along with other document as mentioned in tender document in case of e-bid, amounting to a minimum of valid for 120 days beyond the validity period of the bid after dateline for Bid submission last date.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bidders may withdraw or modify its bids by sending a written notice in a sealed envelope, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB 20.2 before 24 hours prior to the deadline of submission of bids.
9. Bidder may submit modification or withdrawal prior to the deadline prescribed for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
10. Other provisions will be as per prevailing Public Procurement Act 2063 and Public Procurement Regulation 2064 (Amended).
